To help my child at school, I know and understand that:

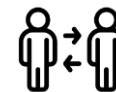
- If my child, or anyone in my household, shows symptoms of COVID-19, I will not send them to school, we will self-isolate for 14 days as a family, I will get them tested and I will let the school know as soon as possible via telephone or email.
- Adhere to the social distancing rules as set out by the government as much as we reasonably can - both in and out of school.
- If my child, or another child in the group, shows symptoms of COVID-19 at school, I will collect my child from school immediately.
- When dropping my child off and picking them up, I will adhere to the 2 metre social distancing rules and remain outside the school gates.
- When dropping off and picking up, I will strictly stick to the school timings for my child.
- My child must not bring any items into school with them or take items home from school (including their reading bag).
- I will need to remind my child about social distancing rules but accept they are difficult to follow and that my child may not always do this successfully.
- My child will need to use good respiratory and hand hygiene.
- I will not be allowed into the school without a pre-arranged appointment - make appointments via telephone or email.
- I need to support all staff in their efforts to create an 'as safe as possible' environment during this crisis.
- Read all letters/messages/emails that are sent home.
- I need to inform the school immediately of any changes to parents/carers and emergency contacts details.
- If my child is deemed unsafe, he/she will be sent home and cannot return to school until they can be safe.

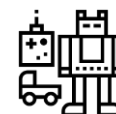

Wash my hands thoroughly.

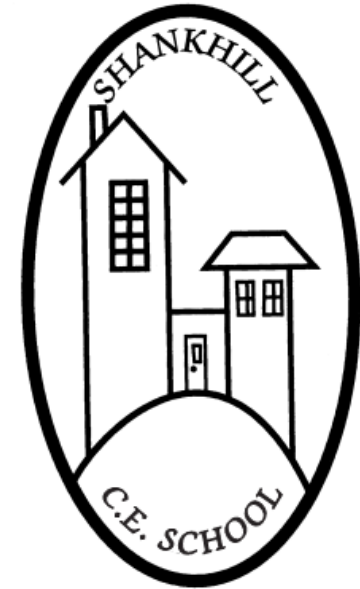
