I hope that you have all had a lovely summer and have enjoyed all the sunshine. Tomorrow, we look forward to welcoming you all back into Shankhill as well as welcoming our new starters to Shankhill. We are excited for the new school year and how everything is looking more normal with classrooms set out with a fuller range of resources, activities and interests as well as new and current friends to return to play with.

I write to confirm our plans for school from tomorrow. School is set up in a more familiar and engaging way for learning with new additions to each class for indoor and outdoor learning. Our risk assessments have all been updated and will be made available to read via our website. On the following pages you will find a copy of the latest school guidance on what to do if your child has symptoms or is unwell. Please retain this for future use.

Within Shankhill we will encourage:

- ✓ Good hand hygiene soap, paper towels and sanitiser are available across the school site.
- Respiratory hygiene the 'Catch it, bin it, kill it' approach continues to be very important when people cough or sneeze. Tissues and lidded bins are available in all rooms.
- ✓ Ventilation and outdoor learning again.
- ✓ Regular cleaning of areas and equipment with a particular focus on frequently touched surfaces and toilets/sinks.
- ✓ Staff continuing with voluntary Lateral Flow Testing until at least the end of September.
- Restricting access to the school site where possible to reduce congestion and because we feel that our current systems work well at the start and end of the school day. We will review this during September. All staff are still available for you speak with. We have more time at the end of the day and so prefer then where possible.

With this in mind, we look forward to welcoming you all back on Thursday, 2<sup>nd</sup> September at 8:45am (school buses) or 8:50am (cars). Please note that the gate will close at 8:55am to enable everyone to settle and learning to begin promptly at 9am. All pupils can be collected from the main gate at 3:30pm. A letter about clubs will follow on Friday. Breakfast club is again available from 8am.

For health and safety reasons, we do not allow children to wear jewellery to school, except for small studs and watches. Pupils must be able to remove and reinsert their own stud earrings for PE and swimming.

In warmer weather, please bring a sun hat and apply sun lotion before school. Ordinarily, we are only outside for 15 minutes in the morning, around 40 minutes at lunchtime and 10 minutes in the afternoon, so one application may well be sufficient.

## Swimming Lessons in September 2021 - Year 4, Year 5 and Year 6 only

As a result of COVID restrictions that were in place, swimming lessons are now in a two week block for Y4, Y5 and Y6 and will start on Monday 6 September and finish on Friday 17 September. Children will travel on the bus (Telfords) from school for the swimming sessions, which will take place each morning at The Pools in Carlisle, and we will return by bus in time for lunch. Mr Neil and Miss Boyd will accompany the pupils.

All pupils will require at least a one piece swimming costume or swim trunks/short shorts; a towel; a bag.

## **Bikeability**

Bikeability training for Year 5 and 6 will start on Monday 20 September and Year 3 and 4 will also have a session with the Bikeability leaders on Thursday 23 September in the afternoon. All children taking part will need to bring their bike to school on Friday 17 September and no later than 9AM on Monday 20 September. More details will follow in September.

## Covid-19 Outbreak Management Plan – Sept. 2021 Advice for parents and staff

When should my child self-isolate or miss school?	NO	•	All children MUST attend school unless they are ill. From 16 <sup>th</sup> August 2021, children under 18 (or double-vaccinated adults) do not need to self-isolate or miss school if a member of their household or a contact, has Covid. Instead, they will need to book a PCR test but can continue coming to school so long as they have no symptoms, and the test result is negative.
	YES	•	If your child develops Covid symptoms at home, they should <u>stay at home</u> and should book a PCR test), <u>NOT</u> a Lateral Flow test. If your child develops Covid symptoms at school, they will be sent home and you should book them a PCR test. If your child tests positive for Covid, they will need to self-isolate. The rest of the household does not need to self-isolate if they are under 18 or fully vaccinated – but instead should book a PCR test.
